**TRIAL THERAPEUTIC CONTRACT**

This contract concerns a trial and observation period for Mr./Ms. \_\_\_\_\_ within the Community, in order to verify their ability to undertake a residential therapeutic treatment.

During the trial months, a protocol for tapering any substitution therapies may also be agreed, in coordination with the referring SerD.

This contract lasts **3/6 (three/six) months**, during which the patient is required to take part in all activities *предусмотр* by the therapeutic programme.

During this initial reception phase, through interviews with the Clinical Lead – psychotherapist, it will also be possible to identify more precisely the issues and matters to be addressed in any subsequent residential therapeutic project.

At the end of the contract, the team and the patient carry out an evaluation of this period: the patient expresses a decision (whether to begin residential therapeutic treatment or other possible solutions), and the team formulates its opinion on the matter. If the opinion is favourable and the patient is motivated to undertake residential therapeutic treatment, the process moves on to signing the final contract.

Mr./Ms. \_\_\_\_\_’s relationships with Community staff have therapy as their sole link.

The team develops the programme and has the function of “observing” and “interpreting” the patient’s overall pathway within the Community.

The President oversees and coordinates the implementation of the activities provided for by the therapeutic programme, assessing both their appropriateness in relation to the guest’s individual plan and the guest’s compliance with what has been agreed. The President also ensures that daily community life remains within the limits set by this contract and by the regulations.

The educators’ role is to help the patient follow all daily activities provided for by the therapeutic programme.

The costs for payment of Mr./Ms. \_\_\_\_\_’s therapeutic treatment are borne by \_\_\_\_\_ – SerD of \_\_\_\_\_.

This contract is signed by Ms. \_\_\_\_\_ as the patient interested in therapeutic treatment and by Dr **ALESSANDRO SARTORI** as the person responsible for the community therapeutic intervention.
